

1. Name : The name of society shall be "Alim Educational Society, Katihar"
2. Registered Office : The Registered office of the Society will be situated at M.G. Road, Katihar - 854105 (Bihar). The place of Registered office may be change at any time by the Society and it will be intimated to I.G. Registration, Bihar.
3. Area of operation : The area of operation of the Society shall be all over India.
4. Aims and objects : The aims and objects and purposes for which the Society is formed and established are the following :

To inculcate interest in learning in general and to provide facility for advanced education and training and to work for the moral and cultural uplift of the Muslim Community in Particular.

- ii) To instil and develop the interest, aptitude and latent capability of Muslim Youths of Bihar in particular and the citizens of other states in

- b) To promote, advance and foster education and culture and to sponsor establish, promote and run educational institutions, providing, special facilities for Muslim Boys and Girls in such a manner as to safeguard, preserve, promote and advance their local languages, culture and religion and to be conducive to the advancement, promotion and progress of the same.
- c) To provide maximum facilities and opportunities to increase the taste and inclination of learning and social and cultural activities by awarding stipends and scholarships or monetary aids to the meritorious and poor Muslim boys and girls.
- d) To establish and manage any where in the country of India, schools, colleges, training institutes, technical and professional institutes, commerce and law colleges, Markaz Taleem-e-Balghen, Edarah Tilsiani (Farighu-L-Tahseel) Dawa Daroo (Fane Moalje) and Tilsiani Farighu-L-Tahseel Jarrahi, free reading rooms libraries and welfare centres and scholarship funds and secure therefore recognition and affiliation from government of Bihar or Universities or other bodies or authorities as the case may be. All educational institutions thus managed by the society shall be opened to all Indian students and for Muslim community in particular. The right to admit students coming from outside India shall rest with the society.

- e) To raise funds for the above objects by subscriptions, donations, or in such other manner as may be resolved upon from time to time including borrowing by unsecured loans on the pledge or mortgage of properties of the trust or means of debenture on such securities as are necessary.
- f) To acquire by purchase, gift, lease, exchange, grant, land, buildings, or other properties both movable and immovable in the interest of the society. All the properties now existing or that may hereafter be acquired shall vest to the society which shall have power to control thereon and manage the same.
- g) To enter into any agreement with government, government or other authorities municipal, local, or other bodies which may seem conducive to the furtherance of all or any of the objectives of society and obtain from such sources any right privileges, assistance and concession which the society may think fit or desirable not inconsistent with the aims and objects of the society.
- h) To manage and deal with the funds and money, land buildings and other properties as aforesaid and to collect rents and income and to invest money in government or reputed and dependable organisation in the safe investment otherwise for the purpose stated above for the benefit of the society and furtherance of its objects.
- i) To start from time to time any such other institutions technical or general including libraries, and scholars funds or to affiliate or take over such existing institutions as the society decides upon for the imparting and spread of education under written agreement.

RULES AND REGULATIONS OF THE BOARD OF TRUSTEES(MAJLIS-E-OMNA) OF
"ALIM EDUCATIONAL SOCIETY KATIHAR"

1. SHORT TITLE AND COMMENCEMENT :

These rules shall be called "The Alim Educational Society, Katihar" rules.

It shall come into force from the date of registration with the I.G. of Registration, Patna, Bihar.

2. DEFINITION :

In these rules unless context otherwise requires :

- a) Rules mean the rules laid down by the society for the time being.
- b) Society means "The Alim Educational Society, Katihar.
- c) Majlise Omna means the General Body that is the Board of Trustees of the Society which shall comprise and constitute of all founder members of the society.
- d) Majlise-Muntajama means the Board of Directors of the Society.
- e) Secretary means the founder Secretary-cum-Managing Director and his successor in office and he shall be the Chief Executive head of the society and the Board of Directors.
- f) President means the President of the Majlise Omna (General Body).
- g) Treasurer means - The incharge of financial accounts of the society "The Alim Educational Society, Katihar".
- h) Institutions means the Institutions running under the society.
- i) Year means the period commencing from the 1st January and ending with the 31st December of the English

- j) Financial year of the society means - the year starting from 1st April and ending on 31st March.

3. MEMBERSHIP :

- 1) Subject to the provision of these rules, the members of the society shall be from Muslim Minority Community having faith in the aims and objects and rules and regulations of the society.
- ii) Any man and woman of more than 21 years of age belonging to Muslim Minority Community, citizen of India, having faith in objects, rules and regulations of the society (Alim Educational Society, Katihar) and always been active for the educational advancement of the community become the members by applying in prescribed form to the Board of Directors of the society which shall have power to reject applications for membership without assigning any reason.

4. CATEGORIES OF MEMBERS :

- a) Founder members : The persons who have established the society will be founder members.
- b) Ordinary members : Such member shall contribute an annual subscription fee of Rs. 500/- and admission fee of Rs. 100/- and this amount shall not be refunded even on the event of cessation of the member from membership.

5. TERMINATION OF THE MEMBERSHIP :

Privilege relating there to shall be deemed to cease if and when a member :-

- a) Resigns or dies or becomes of unsound mind.
- b) Is by competent court declared insolvent or is sentenced to imprisonment for an offence involving moral turpitude.

- c) Is found by the Board of Directors (Majlise Muntazma) to be engaged in activities which are against the interest of the society.
- d) Fails to attend the three consecutive meetings of the Board of Directors (Majlise Muntazma) and the General Body (Majlise Omna) without assigning any satisfactory reason.
- e) If any member of the society ceases to be the Muslim by faith.

NOTE :

Such members will be given show cause notice and after getting satisfactory explanation their membership will be retained otherwise their membership shall be terminated.

6. GENERAL BODY (MAJLISE OMNA) OF THE SOCIETY

- a) The General Body (Majlise Omna) of the society shall comprise and consists of nine members including all founder members at present but the society shall be at liberty to admit other also as a member of General Body by unanimous resolution, provided they fulfill all criteria of the membership.

The members of the General Body (Majlise Omna) shall continue till their lives, vacancies created by death or otherwise (as stipulated in Art. 5) shall be filled in within three months of the occurrence of such vacancies as per the provision in Clause (c) of this Articles.

- c) In the case of vacancies of the membership in the General Body (Majlise Omna), the remaining members of the Body shall fill up the same by co-opting a person or persons eligible for membership for the period and according to the terms as resolved by the society.

7. OFFICE BEARERS OF THE SOCIETY :

- a) The office bearers of the society shall be the President, Secretary and Treasurer.

8. FORMATION OF THE BOARD OF DIRECTORS :

The Board of Directors shall consists of seven members including office bearers.

All members of the society (The ALIM EDUCATIONAL SOCIETY, KATIHAR) shall elect from among themselves four members of the Board of Directors. The members, President and the Treasurer shall hold office for five years unless they are disqualified otherwise during the tenure.

9. BOARD OF DIRECTORS (MAJLISE MUNTAZAMA) :

Subject to the provisions of these rules

- a) The affairs of the society shall be administered directed and controlled by the Board of Directors (Majlise Muntazama).
- b) The Secretary shall hold office for life and shall have a right to nominate any person as his successor during his life.
- c) The members of the Board of Directors (Majlise Muntazama) except the Secretary shall hold office for five years. The old body will continue in office with the approval of the General Body (Majlise Ouna) till new election is held.
- d) In the case of casual vacancy in the membership of the Board of Directors, the Secretary shall fill up the same by nominating any member of the General Body for the remaining period.

10. POWER AND FUNCTIONS OF THE OFFICE BEARERS :

PRESIDENT

- a) He will preside over all the meetings of the General Body (Majlise Omma) and the Board of Directors (Majlise Muntazma) of the society. In the absence of the president, the members present at the meeting shall elect a president from among themselves and the such President shall exercise all such powers.
- b) He will supervise and guide the proceeding of the meeting.
- c) He will have a casting vote, which he will exercise only when there is a tie in a meeting.

SECRETARY

The Secretary shall be the Chief Executive head of the society. He will have right to initiate any motion or resolution if he so likes and speak on any point raised by any member and take part in all deliberations. He may inspect any institution of its department belonging to the society to see its functioning and working.

The Secretary will have the right to call a meeting of the Board of Directors of any of its institutions if he thinks so.

- b) The Secretary may invite any person or persons to take part in the deliberations of Board of Directors. (Majlise Muntazma) but such invitees will have no right to vote.
- c) It shall be the duty of the Secretary to attend to all

general and Muslim Minority Community and weaker sections in

A proper receipt of the society will be given to the payee by the Secretary on behalf of the society.

k) The Secretary of the society shall be the Chief Executive head and Managing Director of all institutions running under the society.

l) The Managing Director of all institutions running under the society shall be paid monthly allowances as per his status and duty of his respective office as fixed by the Board of Directors of the society.

Without prejudice to the general powers conferred by the preceding Articles, it is hereby expressly declared that the Secretary shall also have the following specific powers conferred by the Board of Directors :-

i) To purchase, take on lease or in exchange or hire or otherwise acquire any movable or immovable property for the purpose of the society and carry out agreement, contracts, obligations, arrangements in suitable terms.

ii) To sell, pledge mortgage, exchange lease manage, dispose off or otherwise alienate or deal with any portion of the society's property from time to time.

iii) To borrow or raise funds, in any form for the maintenance and advancement of the objects of the society and to use them in proper manner for the betterment thereof.

iv) To authorise any person or body of persons for dealing with any matter or matters of a particular nature or to enter into negotiations and agreements.

- v) To constitute a sub-committee and delegate to them powers as may be necessary for the purpose for which they may be appointed and to dissolve them at any time and to lay down the procedure of such committee.

TREASURER

The treasurer will be incharge of the fund of the society existing and functioning under the direction and control of the Secretary.

- a) He shall be incharge of the account of the society (Alim Educational Society, Katihar) and shall always be in a position to place before the General Body as well the Board of Directors of the society, the correct and up-to-date financial position of the society. He shall maintain the account and cash book in proper prescribed form.
- b) The treasurer shall be responsible for the issue of receipts, vouchers for funds received or paid out by the Trust, He shall be jointly responsible for receipts and expenditure of the trust.

12. POWER AND FUNCTIONS OF THE BOARD OF DIRECTORS (MAJLISE MURTAZMA)

Subject to the provision of these rules the functions and powers of Board of Directors shall be as follows :-

- a) To carry out, promote and advance the aims, objects and purposes of the society as laid-down in the memorandum of Association of the society as well as implement the directions of the General Body of the society.
- b) To control direct, co-ordinate, guide and supervise all the institutions running under the society.
- c) To administer and control the affairs and funds of the society and exercise all powers of the society.
- d) To do all other lawful acts, matters, things and deeds as may be conducive to or expedient in the interest of the society.
- e) To give approval to the actions taken by the Secretary as mentioned in Article - 10.
- f) To prescribe salaries, emoluments, wages, over time and other legal and necessary, charge payable to the employees of the society and fix and regulated hours of work and declare holidays for persons employed in the society.
- g) To receive and adopt the audited statements or accounts of the different institutions running under the society and transit them to the General Body of the society with its own report for its approval.
- h) To receive and recommend the annual budget estimate of the different institutions of the society to General Body of the society for approval.

- 1) To sanction money to the institutions of the society to meet their deficit in their annual budget as well as for other development works.
 - j) The Board of Directors of the society shall approve the Bye-laws of its institutions before they actually come into operation. Any amendment if so made by the governing body of its institutions the same shall have to be approved by the Board of Directors of the society before they come into operations.
 - k) It shall have power to review the working of the governing body of its institutions in the light of the aims and objects as laid down in the memorandum of association of the society.
 - l) The Board of Directors will preserve and keep in proper state the properties of the society.
 - m) To appoint any committee or committees to help the implementation of the aims and the objects as laid down in the Memorandum of Association of the society.
 - n) The Board of Directors (Majlise Muntazma) shall issue directives to the governing body of its institution when necessary, bear or dispose of appeals against any action of the governing body of the institution of the society.
- The Board of Directors (Majlise Muntazma) of the society shall have power to remove any member of the governing body of its institution on account of legal disability or any mis conduct or any act prejudicial to the institution under the society.

13. PROCEEDING OF THE BOARD OF DIRECTORS (MAJLISE MUNTAZMA)

- a) One meeting of the Board of Directors shall be held at least twice in a year. The duration between the two meetings shall not exceed eight months. Extra ordinary meeting may be convened at any time by the Secretary.
- b) Notice of the meeting of Board of Directors will be sent to the members by post or by special courier. 15 days notice will be given for ordinary meeting and 24 hours for an emergent meeting.
- c) 1/2 members of the Board of Directors present in person shall form a quorum including Secretary.
- d) Each member present shall have one vote including the Secretary in case of equality of votes on any question, President shall have a casting vote.
- e) All meetings of the Board of Directors shall be called by notice under the hand of the Secretary every notice for calling a meeting of the members of the Board shall state the agenda, the date, the time and the place at which such meeting shall be held.
- f) No act or proceeding of the Board of Directors shall be invalidated by reason of any vacancy among the members of the Board of Directors or any defect which is not considered material by the society (Majlise Omma). Proceeding records of the meetings of the Board of Directors shall be kept by the Secretary.

- b) The entire assets of any other institutions that may hereafter be established by the society including movable and immovable properties, land, building shall vest in the society except the aid given to the institutions and fees of the institutions concerned.

15. SOURCES OF INCOME OF THE SOCIETY (ALIM EDUCATION SOCIETY KATIHAR)

The funds of the society shall be raised in the following

- a) Through Phillanthropic donations from the public either in cash or kind or from any other organization or body duly recognized by the government for educational benefit to the society in general and the Muslim Community in particular.
- b) Grant and aid from any other sources.

16. POWERS AND FUNCTIONS OF THE GENERAL BODY (MAJLISE OMMA)

- i) To elect the members of the Board of Directors.
- ii) To approve the Annual Budget of the Society and that of the institutions running under it.
- iii) To amend alter rules and regulations of the society by 2/3rd majority not inconsistent with the aims and objects of the society.
- iv) To sponsor a new institution and cancellation of sick institutions.
- v) The General Body shall also have power to review from time to time broad policies and programmes of its own and to suggest measures to its institutions for safeguarding religious cultural and linguistic heritage of the Muslim Minority Community.

- vi) In matters not covered by the constitution (Bye-Laws) of any institution of the society a decision will be taken by the General Body of the society.
- vii) To hear and dispose of appeals against the decisions of the Board of Directors (Majlise Muntazma).

17. MEETING OF THE GENERAL BODY (MAJLISE OMNA)

The general body meets once a year according to convenience extra ordinary meeting will be called any time. 15 days notice will be given for ordinary general body meeting and 7 days notice will be necessary for extra ordinary general meeting. Notice of the meeting will be sent by ordinary post or by special courier to the members. One third of the members present in person will form a quorum of the General Body meeting. If at an extra ordinary meeting there is no quorum within half an hour, the meeting shall stand dissolved. If at any Annual General Body meeting, there is no quorum within half an hour for the time fixed, the meeting shall be adjourned and no quorum will be necessary for an adjourned meeting.

18. MODE OF FORMATION OF GOVERNING BODIES OF INSTITUTIONS RUNNING UNDER (ALIM EDUCATIONAL SOCIETY, KATI HAR).

- 1) The Governing body of all the institutions shall includes :

- b) Two members elected by the Board of Directors

- 11) The Secretary of the society shall be the Managing Director of all such governing bodies and shall preside over the meetings of the governing bodies in the capacity of the Managing Director.

19. AMENDMENTS

Any amendments, alteration or addition in the rules and regulation of the society can be made in the General Body meeting by 2/3rd majority of the total strength of the society but its minority character shall not be changed in any circumstances.

20. SUIT

Any suit for or against the society will be made in the name of Secretary (Alim Educational Society, Katihar) and the jurisdiction of suit shall be Katihar Court. The Secretary shall have power to sign and verify the pleading and to execute the power on behalf of the Board and may also compromise any suit or abandon any claim in the suit subject to the approval of the general body of the society.

21. DISTRIBUTION OF PROPERTIES AFTER DISOLUTION OF THE SOCIETY: (ALIM EDUCATIONAL SOCIETY, KATIHAR)
