RULES AND REGULATIONS OF THE BOARD OF TRUSTEES (MAJLIS-E-OMMA) OF

"ALIM EDUCATIONAL SOCIETY KATIHAR"

1. SHORT TITLE AND COMMENCEMENT :

These rules shall be called "The Alim Educational Society, Katihar" rules.

It shall come into force from the date of registration with the I.G. of Registration, Patna, Bihar.

2. DEFINITION :

In these rules unless context otherwise requires :

- m) Rules mean the rules laid down by the society for the time being.
- b) Society means "The Alim Educational Society, Katihar.
- c) Majlise Omna means the General Body that is the Board of Trustees of the Society which shall comprise and constitute of all founder members of the society.
